PUBLIC NOTICE

INCREASE REIMBURSEMENT RATES FOR SELECT PRIMARY CARE AND OBSTETRICS AND GYNECOLOGY (OBGYN) CODES

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department of Community Health (DCH) proposes to increase reimbursement rates for select Primary Care codes to 90% of 2024 Medicare rates and select Obstetrics and Gynecology (OBGYN) codes to the 2024 Medicare rates.

For FY 2025, the General Assembly (HB916) appropriated total funds of \$37,334,767 (State funds of \$12,693,821) to increase reimbursement rates for the following programs and codes. Estimated cost for the increase is \$33,663,348 (State funds of \$11,445,538).
