# GEORGIA MEDICAID INPATIENT PROSPECTIVE PAYMENT SYSTEM (IPPS): REBASE TO ALL PATIENT REFINED (APR) DIAGNOSTIC RELATED GROUPER (DRG)

Pending CMS and Board approval, effective January 1, 2024, the Department is proposing to change the grouper from TRICARE DRG to APR DRG. The DRG weights used in the Base Rate calculations would also change. APR DRG is applicable to all patient populations, including obstetrics, newborns, and pediatrics. The TRICARE DRG was designed for the Department of Defense (DOD) and adapted from Medicare's MS-DRG and 3M's AP-DRG.

The state-wide base will change to \$5,985.86. IPPS Rebase will continue to include the four factors that change the hospital base rate from the state-wide rate:

- 1. Pediatric Hospital add-on (\$3,400 per admission).
- 2. Medicaid Inpatient Utilization Rate (MIUR) hospitals that serve more Medicaid patients receive an increase to their base rate, tiered schedule of 2% up to 10% add-on.
- 3. Inpatient Medical Education (IME) hospitals that have graduate medical education programs receive an increase to their base rate (updated annually).
- 4. Stop Gain/Stop Loss mitigates the impact of the IPPS rate update on an individual hospital.
